## Three Legacies

We can't start off the new rotation without saying Happy New Year to Everyone! I want to thank the trusted servants who just completed their service rotation and welcome our newly elected & appointed trusted servants willing to stand for our Groups, Districts, Counties and Area.

We are at the start of Panel 73 and our 2023 General Service Conference theme: "A.A.'s Three Legacies: Our Common Solution". We had our Area Inventory this past November and heard comments from the body. Your officers met and discussed ways to effectively be of service to each member in our Area. We want to be available to all and share information that will be helpful and in an understanding way. Our three legacies; Recovery, Unity and Service are the bedrock we will use to build a stronger and more accessible area where all who want to participate will have that opportunity. Participation is the key to gather information and become fully informed. I encourage all of you to get involved with the general service structure and learn why it is so important that you do.

I received my committee assignment for the General Service Conference on December 9. I will be serving on the Conference Committee on Policy & Admissions. So, what is that? Right?! Here is a quick overview:

Established by 1952 Conference: "That the Conference limit and define this committee's responsibilities to cover only matters of policy pertaining to the Conference itself"; enlarged in 1965 to include "and such other matters as may properly

be placed before it." Further amended in 1974 as follows: "Accepted the recommendation of the Agenda/ Admissions Committee that the 'admissions' function of that committee be transferred to the Committee on Conference Policy."

Admissions function: Is responsible for reviewing all requests for admissions to the Annual Meeting of the General Service Conference; and for approving routine requests for admissions from A.A. service structures outside of the U.S./Canada service structure to observe the Annual Meeting of the General Service Conference.

The Admissions Committee was formed in 1955 when the Conference Charter was accepted as permanent.

My welcome letter had a couple of the agenda items but not the final list which my committee will discuss during the conference, and I am super excited for the opportunity to represent our Area at the Conference this rotation. I will receive the final full list of agenda items in early February and will get them to you asap. The distribution date of the background information is still pending since there was a conference advisory action passed to distribute the background in English, Spanish and French simultaneously. Our Delegates Day of Sharing (DDoS) is scheduled for March 18, 2023.

## **Unity of Being**

The homegroup allows me to learn and practice Tradition 1. It allows me to play a "small part of a great whole". Unity is not something I contemplated or practiced prior to entering the fellowship. My life was built solely on self-will, propelled by the idea that "I know best". For me it was small things that I did or experienced at the homegroup that allowed me to see the wisdom of sacrifice for the Unity and development of the group. These experiences allowed me to practice these actions in my personal life.

Unity is simple as sitting next to others in the meeting rather than putting a chair against the wall or at the back of the room and sitting by myself. I am practicing the principle of Unity by being an active member in my homegroup and being of service. When I help in the "primary purpose of AA", I am in unity with all of AA.

This guiding principle is vital for the homegroup and is the foundation of all the 12 traditions. A group that is not united may not last. Unity within a homegroup or AA as a whole is vital to the stability and continuation of the fellowship. I sometimes will have to sacrifice my ideas and suggestions for the unanimity of the group. Allow the group to make its decision, allow the group to make the mistakes for it to evolve and grow. It is the most important thing we need to ensure that this fellowship will last long after we are gone. I heard many old timers explain that traditions 2 thru 12 is required and should be followed in order for tradition 1 to endure. Similarly, if we do not practice step 2 thru 12 thoroughly and honestly, we may fail at step 1.

I am so excited to share the news that the General Service Office will begin welcoming visitors again beginning Wednesday, October 5. This also includes reinstituting the Friday 11:00 a.m. A.A. meeting. I know this is welcome news, and we are all looking forward to reestablishing this very important spiritual component of the General Service Office.

Much has changed in the two and a half years since we last received visitors, making it necessary for us to make some adjustments. Some key highlights to help make your visit as smooth and special as possible are as follows:

- We will welcome visitors on Wednesday-Friday from 9:00 a.m.-3:00 p.m.
- The Interchurch Center (our landlord) has instituted new security protocols that have changed the logistics of how visitors can enter the office. These protocols require that all visitors be registered into the building system in advance of their visit. We can do this when you arrive; however, contacting us prior to your visit will allow for a quicker and easier entry.
- For groups of 10 or more, please contact us in advance so we can best prepare for your time at the General Service Office.
