The Role of a Service Sponsor

Hello, Friends! It took me a while, but late in 2007 I found the sobriety sponsor that would ultimately take me through the Steps, after 9 or 10 months in the rooms doing nothing. In 2008, when I took my first service commitment as a GSR, it was suggested that I might want to find a service sponsor as well.

When I asked what that was, I was told that it would be someone who would keep me from burning out. Since I had no plans to do anything in service after that, I declined (that worked out well). So I kept serving in different groups, in different positions, for the rest of my sober time in CT – without a service sponsor.

Fast forward to late 2015, after I had moved to Long Island, and suddenly had two major service commitments. All of a sudden, in panic, it finally hit me: I AM about to burn out, I have NO idea how I'm going to handle them, and I DO need a service sponsor. I asked, she agreed, and for the last seven years I've had a loving service sponsor who has gotten me through some pretty challenging times.

But until I came out of the hat for Alternate Delegate four years ago, I always thought that a service sponsor was an entirely different animal than a sobriety sponsor. I now know differently: they are functionally almost identical, and (if you like holding on to your sobriety) a critical component of both recovery and growth.

My sponsor, be it sobriety <u>or</u> service:

1) shares their knowledge and experience with me; 2) helps me see the landmines in the road before I step on them; 3) offers me a sounding board, with humor and without judgment; 4) gives a patient ear to my ventings and rantings; 5) shares with me the bigger picture / longer view of my journey; 6) keeps me focused on the Steps (sobriety) and the Traditions / Concepts (service); and 7) is a close and dear friend. And that list just scratches the surface.

It took four years for Bill W. to get the Steps out in our Big Book. It took him another quarter-century to get both the Traditions and our General Service Structure fully in place. I would say that two good sponsors – sobriety and service – are assets of which we should All avail ourselves!

What a Service Sponsor Does

Have you heard the term "Service Sponsor" since you've been coming around? I didn't hear it until I started service down the triangle. Is a service sponsor the same as a recovery sponsor? In some ways yes - but there are differences in some cases. A sponsor guides newcomers through the 12 steps/12 traditions and makes themselves available to the sponsee to help in their recovery process. A service sponsor is similar wherein a newcomer to service may need guidance. I know when I started service below the group level, I really didn't know much about those levels of service. When we came to the fellowship, we were told to get a sponsor and you shouldn't be without one. Most people listened and asked someone to sponsor them. In service there is a lot to learn and, as with recovery, we are bound to make mistakes. That's where a service sponsor comes in handy. You can ask them questions about service positions you may be thinking of covering. You may have questions on how to plan a workshop or on a concept. You may wonder if you should take on a second commitment. There are loads of situations where a service sponsor can offer suggestions to help you in your service journey. A service sponsor should be someone who has a working knowledge not only of the 12 steps/12 traditions, but they should also be familiar with the twelve concepts for world service. Years ago, someone asked me to be their service sponsor and I didn't think I was qualified so I recommended someone else. Now that I look back, I realize I could have done it. After someone goes through the steps and traditions with a sponsor, our twelfth step tells us we are ready to carry this message. The same with a service sponsor. After doing some service you most likely know some of how things work. Also, one thing I have found is, if you don't know you can always find the answer by asking others who might. That is the beauty of our program. We help each other and never have to go through anything (not even service) alone.

SERVICE SPONSORSHIP

We are all sponsors, both spiritually and in service. Actually, it is difficult to untangle these two roles.



Aren't we all sponsors of every hopeless lost case walking through our doors? Our shared role to impress upon them the spirituality of service. I find it impossible to be a service sponsor without discussing spiritual principles. Isn't a GSR an informal service sponsor to the group they serve - to encourage and inform their members? Isn't a DCM an informal service sponsor to the GSR's of a district? It was a joy and privilege to chair an Area 49 committee and encourage and support committee members - a front row seat to the best show in town. And how many times have I heard a present or past delegate address a topic to the "attention of the future delegates in the room. We can work all three sides of our illustrious triangle from day one of our journey. And, as we go forward on our service journey, more information is needed at different levels. Group conscience, voting procedures, and this guy Robert with the rules already! So much to learn! A sponsor's primary role is to answer questions.

I find something is missing in many AA meetings I attend. There are typically only two shades displayed. Are we a two-legacy fellowship? The concepts, some more than others, are principles for all levels of AA, and might spur the magic moment when someone asks a question.

The Role of a Service Sponsor

The pamphlet "Q&A on Sponsorship" defines "service" as anything that helps us reach another fellow sufferer. "Sponsorship" is an alcoholic who has made some progress in recovery and/or performed service sharing their experience with another alcoholic who is just starting the journey. But aside from that, this is really my opinion about my role as a service sponsor.

As a service sponsor I have a different role than your sobriety sponsor. I defer to your sobriety sponsor on the Steps and personal recovery. Instead, as an AA with experience in service, I am a resource. I answer questions and provide my perspective. If I don't have a ready answer, I say so and find out before answering. I distinguish between answers found in Conference-approved literature and my opinion of how the literature applies.

I ask that you try to respect our process and accept the outcome. When not part of the majority, to set aside that defect of character that is the actor complaining that the other players have not played their parts to our self-centered expectations. A flaw I am as guilty of as any, especially early in service. To take a Tenth Step after an Assembly and recognize that participation was, and acceptance is, the best course of action. Or, as my first sobriety sponsor was so fond of saying, to let go and let God.

It's an AA axiom that "I came for my drinking and stayed for my thinking." As Bill discusses in the pamphlet, "AA's Legacy of Service", the necessity of service to the whole of AA came about early. Out of this came the Traditions, created from our early experiences with the Steps; and the General Service structure and Concepts were founded on both. So I try to show how the Steps, Traditions, and Concepts relate and apply. As you gain experience, I hope that you will begin the process of drawing your own conclusions, because often there are no "right" answers, only differences of opinion grounded in AA literature and prior consciences.

Lastly, our Fellowship is strengthened when we follow AA principles. So I hope that you will share your service with others, so that they gain the benefit of your experience. Michael O.

WHY IT IS SUGGESTED YOU HAVE A SERVICE SPONSOR

A service sponsor is a person who takes on the role of guide to the person new to service, sharing experience, strength and hope in service. It is a long-term relationship, usually initiated at the request of the member to be so sponsored. The relationship is one which can provide the experience of a shared journey in carrying the message to the still-suffering alcoholic.

A good overview on service sponsorship may be found in the pamphlet, "Questions and Answers on Sponsorship", pages 25- 27. There it is suggested that: "A service sponsor is usually someone who is knowledgeable in AA history and has a strong background in the service structure."

In selecting a service sponsor . . . try to find someone whose service attitudes, experience and style you admire. It is always helpful to remember that we have three legacies, and that recovery through the Twelve Steps and unity through the Twelve Traditions are equal sides to the AA triangle.

Service in conformity with the Twelve Concepts should always be seen as closely related to recovery and unity. So, one question to ask in selecting a service sponsor is whether you admire the recovery and adherence to the Traditions shown by the prospective sponsor.

The same attitudes necessary for a GSR should be present in a prospective service sponsor : courage, self-humor, and emotional maturity. A service sponsor should be as kind, non-judgmental and willing to share as a recovery sponsor would be with a newcomer."
