# Delegate's Report (Joann):

- Won the bid for NERASSA in 2027; we had the best presentation
- The motion to make the plain language pass by 3/4ths
- There was a floor action to make an asian american pamphlet
- Transgender alcoholic pamphlet, passed
- Maximum for an individual increased from 5,000 to 7,500
- Convention closed with prayers not including the lord's prayer
- No longer printing [missed] pamphlet
- Edited Black and Alcoholic pamphlet.
- Pla in language revisions,
- Were going to turn
- Proposed deadline agenda item (September
- Floor Actions not acted on (declined to consider)
