General Information / Updates:

- As of yesterday, the *current* count of Proposed Agenda Items for the 73rd GSC is at **184**. The various Trustees Committees will decide (over the next several months) which ones will be forwarded to the GSC. I will post them to our website under From the Delegate as soon as possible.
- Speaking of FTD (From the Delegate), I hope to accomplish a major revision within the next two weeks – my apologies for the delay.

- All 93 current Area Delegates have been a survey to fill out re Online Groups, which I will be completing and turning in this week. At this point they are only looking for the Delegate's response from each Area. I will rely on the feedback I have received from some of you, especially re the Trustees' presentation I made available to you several months ago.
- Along with our own Karina C, GSO has hired two additional new Staff members (one started in late September, and the other will start later this month). I will update you further via FTD and at the November Committee meeting.
- It's official – the GSO office will reopen for visitors this Wednesday, October 5th.
- Continue to visit aa.org/what's new in A.A.

Final SENY Assembly – Saturday, November 12th:

- It will be hybrid, and held at the same place: Westchester Comm College in Valhalla. Buses from Bklyn and Suffolk (via Queens).
- Aside from a full slate of Assembly business, we will also hold our Area Inventory and a special election (first one ever for SENY in a Hybrid environment) for Area 49's candidate for the next NERT.
- Final Assembly of the current rotation – make sure your groups attend (voice... vote... esp. the inventory).

Things to think about for Panel 73 – Officers and Committee Members

Please note that the following random thoughts are from my observations POV, and are subjective in nature. To be clear, I don't have answers to these questions, but the next SENY Committee – ALL of them – need to address them.

The continued decline in participation - my informal poll late in the day last month, 81 GSRs or Alts; 1,800-2000 SENY groups; 4% elect 100%. I thought that was the problem; but now look at these #s:

2020 SENY Elections

(those who stood / max # of votes): Del 10/207; AD 8/191; C 8/191

2022 SENY Elections

(those who stood / max # of votes): Del 5/151; AD 6/145; C 3/140

A 25% drop in voting; *a more-or-less 50% drop in people standing*

How are we going to ask group members to make themselves available to serve as GSRs, when we won't even make ourselves available as officers from the SENY Committee?

Virtual or Hybrid or Live, oh my – in 2-1/2 years, the use of technology for service meetings has gone from a God-send to a bone of contention or, worse, disunifying. Our 1st Tradition, long form: [read]

By the same token, for you DCMs and DCMCs, are you able to reach out and enroll silent groups in the vision of having a voice and a vote, and letting their voices be heard at Area Assemblies?

I'm not seeing it in the numbers I gave you a few moments ago. Think carefully about the decisions you make on that score, yet balance accessibility. Have we gotten too comfortable hiding behind the screen?

Ongoing anger re Advisory Actions of the 71st GSC – the A.A. Preamble; the Plain & Simple Language translation of the Big Book; the changes to the 12 & 12; the sentiment that "it was on Zoom, it wasn't a real conference". Take a look at the PAIs once I post them.

The ongoing effects of the pandemic itself – fear / anger / a "rawness". We've forgotten to socialize / how to simply be with people // how to debate in A.A. love, i.e. "agree to disagree agreeably".

This has been a challenging rotation. You've elected a great group of officers for Panel 73 – but they cannot do it alone. They need an active, fully participating SENY Committee. And they need the voices of more of our Area's groups to be heard.

I'm available to visit your county, district, or group, and remain willing to serve Area 49 any way I can, now and going forward. Thank you for letting me serve all of you.

- Whats the inventory going to look like?
- Joanne is the steward of the inventory.... I'm hoping DCMs and DCMCs will ask the groups to attend. It's a brainstorming question and we want participation...

Treasurer's Report - Rich S - treasurer@aasenya.org

- During the month of September we received 86 contributions totaling \$9,206 and \$397 from the 7th Tradition baskets at the Assembly and Committee meeting for total revenue of \$9,604. This reflects a slowing in our revenue stream as it is 11% below budget for the month and 22% behind last September.
- However, the cumulative results for the year to date remain strong. Contributions for the 9 months totaling \$107,387 are 19% above budget and 16% higher than last year. Total revenue for the period of \$111,328 is 15% above the budget and 9% higher than last year.
- The expenses for the month reflect an uptick as we continue to resume a more normal level of activity post-COVID, but they still remain well below budget. The total expenses for September were \$6,334 which is only 36% of the budgeted amount. The major items included our monthly rent for the SENY office of \$1,500; \$2,466 for the services of Tech 12 at our Election Assembly; \$833 for monthly tech and website expense; \$425 for The LINK; and \$306 for costs associated with the Big Book writing workshop which was held in Orange County on September 17th.
- On a year to date basis, total expenses were well-controlled at \$95,003 which is only 58% of the budget amount with every line below budget.
- The net surplus for the month of \$3,271 increased the year to date surplus to \$16,324 and allowed our operating account balance to rise to \$105,819.26. In addition, we continue to maintain a balance of \$127,133.09 in our Prudent Reserve account which represents 6.98 months of budgeted expenses with \$6,148.16 in our Convention account and \$5,390.34 in the Special Event account.

- So, we continue to do well and are in a strong financial position as we move forward. We will begin working with the Panel 71 and Panel 73 Officers and Committee Chairs on next year's budget later this month.

- We had our last two SENY writing workshops for the 5th ed. English Big Book; one this past Saturday on October 1st in Astoria Queens and in Cornwall NY on September 17.
- On Sept 18, I attended the Asamblea and the NERD meeting. Many came, wrote and read their stories. Thank you for participating. Paola thanks for running the streets with me! The deadline for Spanish stories is December 15.
- I attended the ESCYPAA8 convention planning meeting on September 19th.
- I helped Brooklyn and Manhattan with their county elections.
- I attended Queens Share A Day on September 24 and SoberJam, a three county and WORCYPAA event on September 25 and got to see the DCMCs get drenched in the dunk tank. It was such a fun day with beautiful speakers.
- I started facilitating a group inventory in Warwick NY on September 26 and we will complete it on October 10.
- I will be attending the Queens County Spiritual Breakfast on Saturday October 8 and have another group inventory on October 15.

- We have our Service Participation meeting on October 20th and I will send a reminder the week before.
- I was asked to speak at the Bronx Upper Manhattan SAD on October 22 and will be attending the Putnam Unity breakfast on October 23.
- I am looking forward to the ESCYPAA8 convention coming up on October 28-30. I was asked to help with tech and facilitate a couple of meetings.
- I am also looking forward to our next assembly which is the Area inventory assembly on November 12. I wrote a report back on how our Area did based on the last inventory which I expect to either be distributed via email or be available on our website before the assembly.
- I am still available for group inventories and to speak on traditions and concepts.

Q: Can we advertise this event (inventory)? Maybe get a flyer to get more groups involved

A: That's an excellent idea, thank you!

Technology & Communications Officer (TCO)- Mike O

- My continuing thanks to our technology trusted servants, Claire, Vicky, Derrick, and Justin, for all they have done and continue to do. They really do keep the Area going.
- The Standing Meetings Zoom Account: We've had a few recent cases where users who previously used the account cannot get access unless they go through the Zoom One Time Password process again.
- Over the past 2 weeks I've corresponded with Zoom tech support on why this might happen. Based on what I've found out, this is a sporadic issue with organizations where multiple people share a single account and use the account infrequently and in different locations. Like SENY, especially if Committee does not meet in the summer or the Chair logs in from their summer residence.
- In the meantime, if you are a Standing Committee Chair, please test-start your meeting at least two days in advance of your next meeting; if you have an issue, let me know.

- Groups: According to GSO there are 1,469 active Groups within SENY, plus another 488 Groups whose status is unknown or incomplete, for a total of 1,957 Groups. SENY's records show about the same number. Much of this information predates the pandemic, so Area 49 is gathering information about all Groups within SENY to ascertain whether they are still meeting. This project will almost certainly continue into Panel 73, but our goal is to have a much better idea about what Groups are really meeting within Area 49, and how: physical, virtual, hybrid, or some combination of formats.
- A few last things: although it took place the same weekend as the September Assembly, I was able to get to some of the National AA Technology Workshop online. Justin and I are meeting with Melissa about convention registration. Next weekend Justin and I will be at a GSO meeting to discuss virtual groups, and we have our regular quarterly GSO registrar's meeting coming up as well.
