Treasurer's Report - Rich S - treasurer@aaseny.org

I had the opportunity, along with Sherry P. the Alternate Manhattan DCMC, to serve as a Co-Chair of the Hospitality Committee at last week's General Service Conference. In the true spirit of AA unity and service, our committee came from all over the Area – Long Island, Staten Island, Brooklyn, Manhattan, Westchester, everywhere – a truly diverse and inclusive group. They took our guests all over – from the Statue of Liberty to museums, a Yankee game, walking tours of famous New York areas and neighborhoods, Broadway shows and more. Thank you all for your service and for representing SENY so well. It was greatly appreciated by everyone.

Financial results for the month of April:

- Our revenues continue to be strong and exceed budget.
- We received just over 100 contributions totaling \$10,973 – nearly 10% above budget
- Other revenues included \$377 in the 7th Tradition basket at the Pre-Conference Assembly and \$1,000 in Grapevine Literature sales at the SENY Convention, bringing total revenue for the month to \$12,367 (13.6% over budget).
- Expenses are slowly beginning to return to more normal levels as Covid restriction lift and we resume our traditional service activities. Usual operating expenses for the month were still well below budget at \$4,701 and included \$1,680 in officer reimbursements mainly related to the costs associated with attending the in-person North East Region of AA Service Assembly (NERAASA), the SENY Convention and other area service events; our normal \$1,500 for office rent; \$514 in tech and website expense and \$275 for the April issue of En Lace.
- We also advanced \$12,905 from the Covid Reserve/Contribution account line to cover a portion of the invoice from the Westchester Marriott for the SENY Convention bringing total expenses for April to \$17,706 and creating a net deficit for the month of \$5,239.

- The cash balance in our Operating Account stood at a healthy \$100,585.23 with \$127,122 (6.98 months) in the Prudent Reserve Account, \$6,000 in the Special Event Account and \$6,880 remaining in the Convention Account.
- On a year to date basis through April, our Contribution Revenues are \$54,409, 36% over budget and nearly 20% above last year. After including 7th Tradition baskets and Literature sales, total revenue for the period is \$57,495, 35% above budget and 23% ahead of last year.
- As we have been reporting all year, total expenses of \$46,347, which includes the advance to cover Convention expenses, remain well-controlled with every expense category below budget. Cumulative Net Surplus for the 4 months is \$11,148.
- So, to summarize, we continue to be in very solid financial condition and are well-positioned to fund what I hope are our stepped up service activities for the remainder of the year. I encourage our Officers and Standing Committee Chairs to search out ways to utilize their budgets to provide support and service to our groups and to the entire SENY community.

72nd General Service Conference:

- Many thanks to those who volunteered for Hospitality, including our Co-chair Sherry P; and especially for Rich S, coordinating the activities every day
- I received DQs from 297 different groups, reviewed them thoroughly – also received several from individuals, 4 or 5 past the due date, and a few duplications, all of which I set aside
- Covid super-spreader: started with 133 voting members, by Friday we'd lost over 10% to quarantine in their rooms. Virtual hookup was arranged for observation, but they couldn't participate. Ratio of Area Delegates stayed pretty constant at ~69%, so the groups always had substantial unanimity, had it been needed.
- Favorite Quote: "Blessed are those who have nothing to say, and the courage not to say it".
- By my count, 30 Committee Recommendations and 2 Floor Actions were made Advisory Actions; confirmed with our NERT Francis today that the GSB approved them all.

- At the Post-Conf Assembly I'll talk about the following:

 - Just because you don't agree with someone doesn't mean they are right or wrong- just means we have a diff opinion
- 2) The release deadline for background material in subsequent yrs
 - spanish , french and english

- Problem was I got background in Feb, and got the spanish material in March after DDoS
- Unified for love and service became true
- Logistics problems are present
